Sub: Intimation under Regulation 30 of the SEBI [Listing Obligations and Disclosure Requirements] Regulations, 2015

Further to our earlier intimation to the Stock Exchanges dated January 22, 2025, regarding the receipt of a petition filed by Tamil Nadu Generation and Distribution Corporation (TANGEDCO) before the Hon'ble Tamil Nadu Electricity Regulatory Commission, Chennai, against one of our step-down subsidiaries, M/s. Clarion Wind Farm Private Limited (CWFPL/the Company), we hereby provide an update. The matter, as outlined in the aforementioned intimation, along with the internally assessed potential claim and the estimated likelihood of liability on the Company, is detailed below.

## Chief Financial Controller/Deposits & Documentation, TANGEDCO versus Clarion Wind Farm Private Limited & 80 others

"To declare that the generator M/s. Clarion Wind Farm Private Limited has lost the "captive generating plant status under Rule -3 of the Electricity Rules, 2005 r/w Section 2(8) of the Electricity Act, 2003 for FY 2014-15, 2015-16, 2016-17, 2018-19 and 2020-21 and consequently declare that the users of the said generator are not "captive users" within the meaning of Rule 3 of the Electricity Rules, 2005, furthermore Captive users have consumed electricity over and above the maximum range beyond +10% variation for the financial year 2017-18 and hence the captive user(s) could not be treated as captive consumers for such excessively consumed electrical energy, and pass such further or other orders as this Hon'ble Commission may deem fit and proper in the facts and circumstance of the case and thus render justice."
